Client Type Corporations, organizations and institutions	Either of the following:   1. Free subsequent course to be granted to the outstanding trainee issued to him/her as a "Free Course Coupon" with the Course Completion Certificate; at the end of the completed course; upon obtaining a minimum score of 100%.   2. 	2. A discount of 35% on the course fee to be refunded to the trainee with the certificate upon obtaining a minimum score of 95%. <sup>5</sup>

#### Notes:

- 1. The minimum number of trainees should be 10 (ten) for the corporations, organizations and institutions to be eligible for this discount.
- 2. The number of allowed absence times is 0 (zero) for the trainee to be eligible for this discount. However arriving late for limited number of times may be tolerated.
- 3. The selected course should be one of the scheduled courses and its fee is the same as the attended course. However if the selected course fee is higher than the attended course fee, then the percentage discount shall be 20% divided by the Increment Factor (selected course fee/attended course fee), or if the selected course fee is lower than the attended course fee, then the percentage discount shall be 20% divided by the Decrement Factor (selected course fee/attended course fee).
- 4. The definition of "Group" intended for this plan is the collection of 8 (eight) or more individuals. Each individual should be "Independent" person as defined in item 6. However the individual may be employed or unemployed.
- 5. The number of allowed absence times is 1 (one) for the trainee to be eligible for this discount. However arriving late for limited number of times may be tolerated.
- 6. The definition of "Individual" intended for this plan is any "Independent" person. "Independent" means that the person pays the course or program fee from his/her direct account.
